

**LIGHTEN THE LOAD PROMOTION TERMS AND CONDITIONS**  
**(as at 28 May 2024)**

**1. THE PROMOTION**

- (1) Information on how to enter and prizes form part of these Terms and Conditions. Entry in the Lighten the Load (**Promotion**) is deemed acceptance of these Terms and Conditions.
- (2) The Promotion commences at 6:00pm ACST, Monday 3 June 2024 and closes at 6:00pm ACST, Sunday 23 June 2024 (**Promotion Period**).
- (3) The Promotion is a game of skill.

**2. PROMOTER'S DETAILS**

The promoter is South Aussie with Cosi Pty Ltd ABN 55 152 374 340 of 40 Port Rd Hindmarsh South Australia 5007 (**Promoter**).

**3. ELIGIBILITY**

- (1) Subject to **clauses 3(2) and 3(3)**, entry in the Promotion is open to any resident of South Australia who is 18 years or older (**Eligible Entrant**).
- (2) Employees and their immediate families of the Promoter and Lumo Energy (SA) Pty Ltd (ABN 61 114 356 697) and their affiliates and subsidiaries are not eligible to enter.
- (3) The Promoter reserves the right to verify the validity of each entry. The Promoter reserves the right to disqualify any person for tampering with the entry process or who otherwise does not comply with these Terms and Conditions.
- (4) Each Eligible Entrant may only submit one entry.

**4. HOW TO ENTER THE PROMOTION**

- (1) To enter the Promotion, an Eligible Entrant must comment on the Promotion post in 25 words or less which local sporting club "**Sporting Club**" deserves to win the Prize and why.
- (2) An Eligible Entrant who submits a valid entry by following the process set out in **clause 4(1)**, will be an "**Entrant**" and their entry will be judged in accordance with **clause 6**.
- (3) Entries received outside of the Promotion Period will be ineligible for entry. Entries are deemed to be received at the time of receipt by the Promoter. Records of the Promoter are final and conclusive as to time of receipt.
- (4) Any Entrant found to have used multiple social media accounts to enter will be ineligible.
- (5) An Entrant must not submit any entry:
  - (a) that contains images of another person without that person's permission (or in the case of a minor, the minor's parent(s) or legal guardian(s) permission);
  - (b) for which a third party holds the intellectual property rights where the Entrant has not obtained all necessary consents to copy, disclose, distribute, incorporate or otherwise use the material for any purpose;
  - (c) that is discriminatory, obscene, pornographic, defamatory, liable to incite racial hatred, in breach of confidentiality or privacy, which may cause annoyance or inconvenience to others, which encourages or constitutes conduct that would be deemed a criminal offence, give rise to a civil liability, or otherwise is contrary to the law in Australia; or
  - (d) that may be used in connection with spamming, phishing, trolling or similar activities.

(6) Unacceptable entries may be deemed invalid, at the Promoter's sole discretion.

**5. THE PRIZE**

The Promoter is offering Eligible Entrants the chance to nominate a local sporting club they feel deserves support and for the chance to win a cash prize for the amount of \$2,000 (incl GST), issued in accordance with **clause 7 (Prize)**. The Competition Winner and Sporting Club will also be filmed for a segment on South Aussie with Cosi.

**6. PROMOTION WINNER**

(1) All judging decisions are at the discretion of the Promoter and no correspondence will be entered into in this regard. Judging criteria: All entries will be judged on creativity, literary merit, originality, suitability, or as otherwise specified. The Entrant selected by the Promoter will be determined to have won the prize (**Promotion Winner**).

(2) The Promotion Winner will be selected by the Promoter at 3:00pm ACST on Monday 24 June 2024 at 40 Port Road, Hindmarsh, South Australia.

(3) The Promoter will notify the Promotion Winner before 5:00pm ACST on Monday 1 July 2024 by:

(a) private online message to the Promotion Winner's Facebook account that posted the entry, in which it will request contact details for a representative of the Sporting Club; and

(b) publishing the name of the Competition Winner and the Sporting Club on the Facebook page of the Promoter.

(4) If the Promotion Winner:

(a) responds to the private online message before 5:00pm ACST on Friday 5 July 2024 acknowledging that they have won the Promotion and providing the requested contact details including email address and phone number for the representative of the Sporting Club, they will have been deemed to have won the Promotion (**Winner's Acceptance**); or

(b) fails to respond by 5:00pm ACST on Friday 5 July 2024, the Promotion will be deemed to be open and a new Promotion Winner will be selected in accordance with clause 6(1).

(5) If the Promotion Winner responds to the Promoter in accordance with clause 6(4)(a), the Promoter will contact the representative of the Sporting Club using the contact details as provided by the Promotion Winner to advise them that they have won the Prize.

**7. PRIZE DETAILS**

(1) Within a reasonable time frame after the Winner's Acceptance, the Promoter will contact the Promotion Winner and a representative from the Sporting Club directly to arrange payment of the Prize to the Sporting Club upon payment of which the Sporting Club will be deemed to have accepted the Prize (**Prize Acceptance**).

(2) It is a condition of winning the Promotion that the Promotion Winner and the Sporting Club attend the filming of the presentation of the Prize for a TV segment on South Aussie with Cosi. The date of the filming will be confirmed by 31 July 2024.

(3) For the avoidance of doubt, winning the Promotion does not in any way make the Promotion Winner a beneficiary of or entitled to any part of the Prize.

**8. OTHER MATTERS RELATING TO THE PROMOTION**

- (1) It is a condition of winning the Promotion that the Promotion Winner and the Sporting Club may be required to sign a release of liability in a form to be determined in the absolute discretion of the Promoter.
- (2) If a Prize or receipt of it incurs a tax liability, the Promoter is not liable for payment of such tax.
- (3) The Prize cannot be transferred or exchanged.
- (4) Prize Acceptance is deemed consent for the Promoter to use the Promotion Winner's details, voice, image, likeness and photographs as well as the details and associated intellectual property including logos, details, photographs and name of the Sporting Club for promotional, marketing and publicity purposes on the Promoter's website or in other forms of social media or on other websites or in any other media used by the Promoter for an indefinite time without any further attribution, reference, payment or other compensation to the Promotion Winner.
- (5) Each Entrant must comply with any requirements for the use of Facebook, and his/her Facebook account. This Promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook. The Entrant understands that the Entrant is providing its information to the Promoter and not to Facebook. The information the Entrant provides will only be used for prize notification, competition related announcements and the Promoter's communications. By entering into this Promotion, the Entrant agrees to release Facebook from any or all liability in relation to this Promotion. Any questions, comments or complaints regarding the Promotion should be directed to the Promoter and not Facebook.
- (6) Each Entrant acknowledges that the public will have the capacity to comment on the entry, and will not hold the Promoter liable for the publication of any comments, whether derogatory, offensive, racist, defamatory or otherwise, posted in relation to the entry.

**9. PRIVACY**

By entering this Promotion, each Entrant is taken to consent to the Promoter using the Entrant's personal information to administer the Promotion and disclosing the Entrant's personal information to organisations that assist the Promoter with administering the Promotion to third parties as required by law. If the information requested is not provided by the Entrant, the Entrant may not participate in the Promotion. - (1) Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Australian Consumer Law (Schedule 2 to the Competition and Consumer Act 2010 (Cth)), or similar state-based consumer protection laws (**Non-Excludable Guarantees**).
- (2) Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and its related bodies corporate (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity) whether direct, indirect, special or consequential, arising in any way:
  - (a) out of the Promotion; or
  - (b) without limiting clause 10(2)(a), out of: (i) any technical difficulties, equipment malfunction, any delayed email, any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical problems or traffic congestion on

the internet or any website (whether or not under the Promoter or its related bodies corporate's control); (ii) any theft, destruction, unauthorised access or third party interference of entries under this Promotion; (iii) any entry or Prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter or its related bodies corporate; (iv) any tax liability incurred by a Promotion Winner or Entrant; or (v) use of a Prize.

**11. VARIATIONS**

- (1) The Promoter in its sole discretion may modify, suspend or terminate all or part of the Promotion, or disqualify and prohibit further participation in this Promotion, in the event that any portion of this Promotion is compromised by a virus, bugs, non-authorised human intervention, hackers or other causes beyond the reasonable control of the Promoter which, in the sole opinion of the Promoter, corrupts or impairs the administration, security, fairness, or proper conduct of the Promotion.
- (2) The Promoter reserves the right to update these Terms and Conditions from time to time in its sole discretion for administrative reasons or to ensure efficient operation of the Promotion.
