

HUMPHREY 60TH BIRTHDAY FOR ALL

COMPETITION TERMS AND CONDITIONS

South Aussie with Cosi Pty Ltd (**South Aussie with Cosi, we, our or us**) is giving you the chance to win a family pass to Humphrey 60th Birthday for All Event at the Adelaide Zoo (9.30am Saturday 25th October, 2025)

By entering the *Humphrey 60th Birthday for All* Competition (the **Competition**) you are agreeing to the following Terms and Conditions:

1 PRIZE DETAILS

- (a) There will be one hundred **prize winners** selected from all entries received online and **each prize winner** will receive a family pass for a group of 4 people (referred to as a "**Family Pass**").
- (b) Each Group Pass is valued at \$120 and the total prize pool is valued up to a maximum of \$12,000.
- (c) In the event that the family who nominates has less or more family members than 4 the prize distribution will be left to the discretion of South Aussie with Cosi.
- (d) The prize value is correct at the date of publication. South Aussie with Cosi accepts no responsibility for any change in prize value between now and the date on which the prize is received.

2 WHO CAN ENTER

- (a) Entry is open to all residents of South Australia aged 18 years and over.
- (b) Prize Winners must be able to attend the *Humphrey's 60th Birthday for All* (the **Event**) on Saturday October 25 at 9.30am at Adelaide Zoo.

3 HOW TO ENTER

- (a) The Competition commences Sunday 21 September 2025 at 17:30 ACST and concludes on Wednesday 1 October 2025 at 23:59 ACST (**the Competition Period**).
- (b) In order to enter the Competition, participants must:

 - (ii) Complete all required fields in the competition entry form and submit an entry by telling us something about your child and why they don't get invited to parties.
- (c) Entries that comply with clauses 3.3(a) and 3.3(b) and all other Terms and Conditions will be deemed a valid entry (**valid entry**).
- (d) Participants may only enter once.
- (e) Participants can only win one (1) prize per person.

4 GENERAL TERMS

- (a) There is no entry fee and no purchase necessary to enter the Competition; therefore we won't ever ask you for your credit card or bank account details.

- (b) No further entries to the Competition will be permitted after the closing date/time.
- (c) It is the entrant's responsibility to ensure that their contact details are correct and we accept no responsibility for errors in contact details or entries not received for whatever reason.
- (d) Any changes to a Competition will be publicised (and where practicable notified to entrants) as soon as possible.

5 SELECTION AND NOTIFICATION OF WINNERS

- (a) The winner selection will take place on Thursday 2 October 2025 at 09:30 ACST.
- (b) We will publish the Winner's names on our website and/or social media (such as Facebook).
- (c) Winners will be notified within 2 business days of selection.
- (d) The results of the Competition will be made available by posting details on any one or more of our media platforms within 30 days.
- (e) Our decision is final and we will not enter into any communications regarding the result.
- (f) We may in our absolute discretion determine that one or more entries are invalid, including subsequently to a winner being notified or a winner's name being announced where it is determined that these Terms and Conditions were breached or not otherwise complied with.
- (g) If for any reason the Competition is not able to be conducted as planned, due to causes including but not limited to tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of South Aussie with Cosi which corrupt or affect the administration security, fairness, integrity or proper conduct of the Competition, South Aussie with Cosi reserves the right in their sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the Competition, subject to state government legislation.

6 UNCLAIMED PRIZES

- (a) We will aim to distribute all prizes in the Competition and will take every reasonable effort to identify and contact an entrant selected as a winner.
- (b) We will allow a reasonable period within which the person may claim their prize.
- (c) If a person selected as the winner of the prize does not claim the prize within a reasonable time or if we or the Prize Giver have made a reasonable but unsuccessful effort to identify or contact the person, or if a winner is later deemed ineligible, we may substitute another person as the winner using a subsequent draw.

- (a) By entering the Competition, the Winner agrees to our use of their name and image in any marketing material, as well as their entry.
- (b) The Competition is in no way sponsored, endorsed or administered by, or associated with, Facebook or any other social media platform.

8 PRIVACY

We have adopted a Privacy Policy that you should refer to in relation to how we collect and use personal information. We will only use Competition entrants' personal information in accordance with these Terms and Conditions and our Privacy Policy which is published on our website.

9 LAW AND LIABILITY

- (a) These Terms and Conditions are governed by and shall be construed in accordance with the laws in force in the state of South Australia.
- (b) It may be a condition of accepting the prize that the winner may be required to sign a legal release in a form determined by South Aussie with Cosi or the Prize Giver in its absolute discretion.
- (c) We will not be liable for any circumstances in connection with the Competition which are beyond our reasonable control, including cancellation or postponement of the Event and/or cancellation or postponement of the Competition for any reason including but not limited to the COVID 19 pandemic, vandalism, power failures, tempests, natural disasters, acts of God, civil unrest, strike, war, act of terrorism.
